Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Model Deed of Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session and the Congregational Board are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts, Christian maturity and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. The Congregational Board consists of eight elders appointed by the Kirk Session and a further eight members elected from within the congregation. These are people who are believed to have the skills and commitment to contribute to the management affairs of the Church. Board Members are elected at the Stated Annual Meeting and serve for a period of three years after which they may seek re-election

Organisational Structure

The Congregational Board is chaired by the minister and meets bi-monthly and at other times as required. The Board has Finance and Property Committees, and though it has not proved possible to appoint a Property Convener, the Committee is working well. The Kirk Session, which also meets bi-monthly and at occasional additional times, is responsible for spiritual affairs within the church. The Kirk Session has a worship Committee and during the year re-structured its strategy for pastoral care. At a local level, Slateford Longstone has a number of joint activities with nearby congregations.

Objectives and Activities

Slateford Longstone is part of the Church of Scotland, which is Trinitarian in doctrine, Reformed in tradition and Presbyterian in governance. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Worship: Services are held on Sunday mornings, with Communion celebrated on the first Sunday of each month. Attendance on Sunday mornings is generally between 70 and 80. The "New Month – New Worship" series with St David's Broomhouse continues plus our own monthly Prayer Service. Other special services are held from time to time, particularly during the Christmas and Easter seasons, including a series of joint services in Holy Week.

Service: The halls are made available at reasonable cost to a wide range of community groups, including Alcoholics Anonymous, a Mother and Toddler group, and the Lighthouse Chapel, whose attenders are mainly of Ghanaian origin. Members of our congregation deliver Christmas greeting cards from the congregation around the parish, plus invitations to the summer holiday club.

Group Activities – in their own words

Fair Trade Stall: During 2012 the stall was open seven times and sold over £800 of fairly traded goods — usually foodstuffs but cards and gifts were available for Christmas. £88 profit was made and this was donated to Operation Christmas Child to help with transport. Thanks to all who support Fair Trade; it really makes a difference to the producers.

Sunday Club: In Sunday Club we have a core of around 8 ranging in age from 3-10 years. Leaders are still Yvonne Paterson and Suzanne Riddoch but a change in circumstances for Yvonne will mean she is only able to come along every second Sunday, and there is a need for volunteer help. Each week the children bring along an offering and as these build up we buy gifts from Christian Aid twice a year. The children are very engaged with this activity and we often have to use a voting system.

Lazer Group runs on Sundays catering for young people from P7 through high school. At present we have two regular members, Connor and Emily. We use the Scripture Union books The Grid to help discuss issues around the Bible and faith. This year our entry for the Moderator's Medal received a letter of commendation. Both our members took part in the Harvest service and Emily spoke at the recent service focussing on HIV/Alds. Ros and Maggie are enjoying their role as Lazer leaders.

TakeAway Club: TakeAway Club continues to meet on Friday afternoons with the aim of helping young folk learn about Jesus and how he can change their lives. The leaders are encouraged by the faithful attendance of the kids and their enthusiasm to take part in activities and prayers. We enjoy hearing them share what Jesus means to them. During the year we looked at "Target Challenge" which introduced the kids to David. We ended the year with "Awesome" where we looked at the miracles of Jesus John's Gospel. The kids were full of amazement and enjoyed acting out some of the events.

Holiday Club: The title for 2012 was "On Your Marks", and had a topical Olympics theme. The

spiritual focus was on what it means to be part of Jesus' team. An average of 50 children attended and the club concluded with a barbecue for families with outdoor Global Games. The club is a significant part of our outreach to the parish.

Operation Christmas Child: We have collected for the Samaritan's Purse shoe box appeal for over twelve years now. It is well supported by the whole parish. Leaflets are delivered around the parish with the option of donating a couple of items for a box, a whole box or a monetary donation. A number of members who collate all the items, fill the boxes and do fundraising for the postage costs. In 2012, we managed to fill 316 boxes transported once more to Belarus.

Choir: I (Marion Henderson) took over as Music Leader in December. It was a busy month, with all the services and an augmented choir singing at the Corn Exchange. The regular Choir, though small in number, do very well and cope with the challenge of new hymns.

Guild: We meet weekly on Tuesday evenings from October to May. While some Guild branches elsewhere are closing down due to lack of support, we feel fortunate to still have 40 members and to be able to sustain a full programme of meetings and fund-raising events, including in 2012 celebrating 60 years together with a dinner at Carfraemill Hotel, Lauder. The cake was cut by Alice Fergus, a member for 58 years. New members – both men and women – are always welcome.

Over 50s: We continue to grow in strength, and now have 55 members. A very successful Tea Dance was held on the 14th of June, to celebrate the Queen's Diamond Jubilee. There has been a varied programme, with music, quizzes, excellent speakers, and subject matter to suit all tastes.

Start!: There was a small attendance at this year's course, but as always it has proved an effective way of exploring the faith and stimulating discussion on what it means to follow Jesus.

Achievements and Performance

Membership: The year was marked by a quite significant loss, either through death or moving away, of a number of key members who had been at the heart of the congregation's life, some for many decades. With no new members added, the number on the Communion Roll dropped from 261 to 240.

Developments: The church **website** has now been active for several years and attracted an average of some 6,850 "page impressions" (individual viewings of web pages) each month. It can be found at www.slatefordlongstone.org.uk and is an increasingly important part of our communication strategy. Kirk News continues to be published quarterly and is delivered to members of the congregation.

The Kirk Session had found it increasingly difficult to provide **pastoral care** through the traditional district system; having completed our review of members' wishes and possible alternatives, we established a Pastoral Care Team, together with a carefully chosen group of Church Visitors. This allows for a more focussed and hopefully more effective strategy for pastoral care. The members of the Team are:

In May **Alasdair Macmillan**, a ministry candidate, completed his eight month part-time placement. The congregation had warmed to him and has invited him back to lead worship and speak at meetings.

Property Review

The Congregational Board does what it can with limited financial resources to maintain the church properties in good condition, and is heavily dependent on volunteer maintenance where practicable. The Board has now almost completed the urgent and important repairs highlighted by the Presbytery's survey of 2010. In addition, two major repairs were undertaken. At the manse the dilapidated sun lounge was demolished and replaced by a better and well-insulated structure. At the church premises, the roof of the Activities Hall needed renewal after years of dampness spreading through it. The Board is indebted to the General Trustees and to Edinburgh Presbytery for grants which gave significant assistance to undertaking these works. There was also a sponsored walk down the length of the Water of Leith Walkway which raised over £1000 towards the roof repair. Cracked rendering on the walls of the halls was repaired, and a new study window installed at the manse.

Financial Review

Unrestricted expenditure exceeded unrestricted income by £2,266 for the year, which was met out of reserves brought forward. £1,785 of this related to Fabric Fund leaving a deficit of £481 on our General Fund.

Unrestricted reserves at 31 December 2012 amounted to £8,359 (2011 - £10,625). The budget for 2013 shows general expenditure of £59,722, this we anticipate to be met from General Income including some fund raising activities.

Reserves Policy

The congregation had unrestricted funds of £8,359 at 31 December 2012 (2011- £10,625). This is considered to be adequate to continue the current activities.

Statement of Trustees' Responsibilities

In common with all charities the trustees recognise their responsibility to prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the charity during the year. In preparing those financial statements, the trustees are required to:

- Select suitable accounting policies and apply them consistently;
- Make judgments and estimates that are reasonable and prudent;
- State whether applicable accounting standards and statements of recommended practice have been followed;
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operational existence.
- To keep proper accounting records which, on request, must reflect the financial position of the charity at any time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, and the Charities Accounts (Scotland) Regulations 2006 as amended.
- Be responsible for safeguarding the assets of the charity and to take reasonable steps for the prevention and detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Slateford Longstone Parish Church

I report on the accounts of the charity for the year ended 31 December 2012 which are set out on pages 8 to 17.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 as amended.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006 as amended. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

1. Accounting policies

- a. The accounts have been prepared under the historical cost convention, and in accordance with the Charities and Trustee Investment (Scotland) Act 2005, The Charities Accounts (Scotland) Regulations 2006 as amended, the Regulations anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007 and the Statement of Recommended Practice: Accounting & Reporting by Charities (2005)
- b. Voluntary income is received by way of donations and gifts, income tax recovered under Gift-Aid and legacies. This income is included in full in the Statement of Financial Activities when receivable. The value of services provided by members, adherents and volunteers has not been included.
- c. Resources expended are recognised to the particular activity where the cost is related directly to that activity, and when that cost is incurred.
- d. The church is recognised as a charity for the purpose of applicable taxation legislation and is therefore not subject to taxation on its activities. The Church is not registered for V.A.T. and resources expended therefore include irrecoverable input V.A.T.
- e. The Church including Halls and the Manse, are vested in the Church of Scotland General Trustees. The value of these heritable properties are therefore not recorded in the Accounts.
