George & Margaret Shand, Jerusalem: As previously advised George & Margaret Shand will be on deputation in late April, and a meeting has been arranged for all interested at Slateford Longstone on Tuesday 23 April at 3.00pm.

Fairtrade: Presbytery passed a resolution encouraging congregations to seek Fairtrade status, which involves supporting Fairtrade Fortnight, promoting Fairtrade products and using them at all meetings for which the congregation has responsibility. The Church will buy Fairtrade tea and coffee and provide to the Guild and Over

50s groups to try. We will get feedback from their members and if this is positive we can consider moving towards becoming a Fairtrade Congregation.

Welfare Reform: Presbytery is encouraging congregations and office bearers to be well informed about the changes to the benefits system. It was agreed we will hold off on getting any further information on this for now. **Public Entertainment Licences:** The City of Edinburgh Council has now agreed to exempt certain events for the need for a licence.

- a) Free to enter events where the capacity is less than 500.
- b) Public entertainment events where the capacity is less than 250 and the organisers are e.g. a religious group, even if an entrance fee is charged.
